

PRIVACY POLICY

This Privacy Policy applies to the website of MOYERSOEN NV.

The Privacy Policy provides you information about your personal information that MOYERSOEN NV collects, and the ways in which MOYERSOEN NV uses that personal information.

MOYERSOEN NV respects the privacy of the users, in accordance with the law dated 8 December 1992 relating to the protection of privacy and its execution degrees. This law defines “personal information” as: “every data concerning an identified physical person”. Examples of this personal information can be: name, address, domicile, fix or mobile phone number, e-mail address.

THE USE OF THE PERSONAL INFORMATION

MOYERSOEN NV collects and processes data about clients and visitors to this website that MOYERSOEN NV esteems to be necessary for its intern company functionality. MOYERSOEN NV also uses this data to adjust its services and products to the user, to improve the content of its website and to contact the user in case he wants to be informed about possible promotions of some products (unless the user has declared explicitly not to receive any offers regarding services or products). The data will not be announced nor transferred to third persons.

COLLECTING PERSONAL DATA

MOYERSOEN NV may collect and use the following personal information:

- All information about the pages the user has consulted on the website.
- All personal information that is needed for the registration to the website. (Name, address, VAT-number, fix or mobile phone number, email address...)
- The duration of the user session.

COOKIES

Cookies are used on this website. A cookie is a small file that contains information about the behavior of the website visitors. The cookie is stored on the user’s hard drive. The cookie that is created by MOYERSOEN NV offers the opportunity to collect information about the use of the website, the duration of the user’s session, the choice of language.

WEBSITES OF OTHERS

This website contains links to other websites. In such case, MOYERSOEN NV has no control of those third privacy policies. By using these extern websites, the user himself takes all risks and becomes subject of the privacy policy of those third persons. MOYERSOEN NV cannot be responsible for the policy of the owner or operator of those internet sites.
